duly sworn according to law, states that a criminal offense has been committed in Knox County, Tennessee, by the defendant,  
DAVID ALEXANDER HAYES (ALIAS) - IDN 1306989 whose last known address is  
241 HAWTHORN, KNOXVILLE, TN 37920

Further, affiant makes oath that the essential facts constituting said offense, the date of said offense, and the sources  
of affiant's information concerning said facts are as follows:

THE DEFENDANT COMMITTED THE OFFENSE OF DISORDERLY CONDUCT (UNREASONABLE NOISE), IN VIOLATION OF TCA SECTION 39-17-305.  
THIS INCIDENT OCCURRED ON OR ABOUT FRIDAY, MARCH 11, 2016 AT 01:42 AT WALL AVE MARKET SQUARE STAGE. ON 03/11/2016 AT 01:39  
HOURS, THE DEFENDANT WAS ON WALL AVE NEAR MARKET SQUARE STAGE AND KEPT INTERFERING WITH OFFICERS WHILE THEY WERE  
TRYING TO PUT A INDIVIDUAL INTO THE SQUAD CAR TO BE TRANSPORTED TO THE HOSPITAL FOR MEDICAL CARE. WHILE OFFICERS WERE  
DEALING WITH THE SICK INDIVIDUAL THE DEFENDANT CAME INTO THE MIDDLE OF THE ROAD WAY AND REFUSED TO GET OUT OF THE ROAD  
AND WAS BLOCKING IT SO OTHER VEHICLES COULD NOT PASS. DEFENDANT THEN BEGAN YELLING DEMANDING OUR NAMES AND BADGE  
NUMBERS SAYING THAT HE DID NOT TRUST US TAKING THE INDIVIDUAL TO THE HOSPITAL. DEFENDANT REFUSED TO LEAVE THE ROADWAY  
AND REFUSED TO QUIT YELLING. DEFENDANT WAS TAKING INTO CUSTODY. THIS DID OCCUR IN KNOXVILLE, KNOX COUNTY, TN. A CITATION  
WAS NOT ISSUED BECAUSE LIKELY THE OFFENSE WILL CONTINUE.
